For Power BI, as many students have not had exposure to Power BI, we will utilize this program in class for workshops so understanding the basics of importing data, formatting data and adding visualizations to your dashboard will be sufficient for the course.

You will only need Power BI Desktop for this course, we will not be using the Power BI service. It is a free download here: <https://www.microsoft.com/en-us/download/details.aspx?id=58494>

## Course Description

This course is designed to provide a comprehensive understanding of project cost management, data analytics, and the application of Power BI tools for visualization. Through in-depth analysis, students will learn how to identify potential cost overruns early in the project lifecycle. By analyzing real-world project cases, students will build a comprehensive portfolio of skills tailored to address the challenges of cost management and data-driven decision-making in project environments. Upon completion of this course, students will be empowered to proactively identify, analyze, and mitigate cost overruns, driving project success and delivering value to stakeholders.

## Course Objectives

At the end of this course, you should be able to:

- Analyze real-world examples of unsuccessful attempts to manage project cost overruns and apply the lessons learned to future projects.
- Implement strategies to address cost overruns and deviations from the budget.
- Explore strategies for recovering from cost overruns and cost-cutting measures.
- Understand how capitalizing versus expensing project costs can affect the financial statements.
- Create interactive and dynamic project dashboards using Microsoft Excel and Power BI.

## Course Organization

### Canvas

The course will utilize Canvas for all material needed. All course deliverables are included in Canvas. Class material is contained within the Modules tab in Canvas and organized by class session. Important class information will be communicated via Canvas, including class being moved to a remote environment, through announcements so please make sure to check frequently and have your announcements turned on. This course is broken into 4 Modules. Each module will have reading assignments applicable to the content for that module as well as articles or case studies on real projects that we will analyze during class. You are expected to have read the material prior to class based on the schedule that is posted in this syllabus.

Your final grade depends on the extent to which you demonstrate the capacity to think critically about project cost management that is demonstrated through in class discussions and application of cost management concepts through the final presentation.

Any grading disputes must be communicated within 1 week of receiving the grade. After this point no adjustments will be made.

### Class Participation

Class participation will be an integral part of your learning experience in this course. Your participation will be assessed during class and you will also self-assess your participation twice during the mini. This includes demonstrating being prepared for class, participating and adding insights to class activities, contributing to both small group discussions and larger group discussions.

Attendance will also contribute to your participation grade as you cannot be an active participant if you are not in class. You may miss 2 classes for any reason (job interview, sickness, deadlines, etc) and you have the option to notify me if you will miss, however it is not required.

### Classroom Behavior

It is expected that you will arrive on time for class. Situations may infrequently occur where you may need to arrive late, however please come in quietly to not disturb the lecture and your fellow classmates. Laptops/ipads are allowed to be used during class, however you should not be working on

other classes or messaging with friends. No cell phone use is permitted during class sessions. It is very apparent if this is occurring, and this will be reflected in your participation grade.

## Discussion Board

There will be a discussion board for each of the Modules during the course. Please note that there are no extensions for discussion board participation. To earn full credit, you will need to post by the deadlines. Please pay careful attention to the grading rubrics for the discussion forum.

Your insights from your prior experiences combined with the course material are valuable to the discussion boards and the course content. You must make 1 original post in response to the discussion prompt and 1 response to a classmate during each module.

## Assignments & Quizzes

There will be individual assignments during the course which will be submitted in either Canvas or through workshops via direct observation. Any questions related to the assignments should be addressed during lecture or office hours so please do not wait until the last minute to look at the assignment.

Your work is to be completed individually on the assignments, your answers should be in your own words. This is defined as you should not have the exact same sentences as your classmates. You are welcome to ask other students questions but completing the assignments together is not permitted. Having possession of another student's assignment in any form is considered an Academic Integrity violation and will not be tolerated. Assignments will be checked for plagiarism using the Turnitin application.

Further details of the specifics of the assignment submission guidelines are contained in each assignment. Assignments turned in after the due date will be eligible for a maximum of 90% of the original grade. You will have 24 hours past the due date to turn in the assignment for the reduced grade, past that time frame no assignments will be accepted.

There will be 4 mini quizzes through the course for the purpose of comprehension checks of the contents of each Module. The quiz can be completed at any point during the open window listed on Canvas. You can use any course materials to complete the quiz. Late quizzes will not be accepted.

## Final Project

This course will culminate with you presenting on a cost overrun project of your choice. You will need to present the following on each project, the background of why the project was undertaken and then will address topics from each of the modules in the course: resource planning, cost estimation, cost budgeting and cost control. More information will be communicated during the course on the final project.

## **Academic Integrity**

All assignments that you are submitting should be in your own words, not classmates and not directly taken from the books or online resources including financial statements. You may work with classmates to discuss assignments and ask questions, but the assignments are to be completed individually. I will be checking for plagiarism amongst assignments which includes having the same sentences as a classmate. Cheating on assignments or exams will not be tolerated and will be communicated to Your Program Director, The Associate Dean and The Dean of Student Affairs at the University. If you are caught cheating, your final grade will be reduced by 2 letter grades.
